UL de México supports you by providing inspection services to demonstrate compliance with commercial information standards through the issuance of a Compliance Certificate or Compliance Report.

Certificate called Constancy: Document issued by the Inspection Unit as a result of the Conformity Assessment performed on labels or products to determine compliance or non-compliance with the requirements established by the Mexican Official Standard.

Opinion: Document issued by the Inspection Unit to importers as a result of the Conformity Assessment carried out during the on-site inspection visit to determine compliance or non-compliance with the requirements established by the Mexican Official Standard.

➤ **Accredited Standards**

- **[NOM-004-SCFI-2006](#), Commercial Information. Labelling of textiles, clothing, accessories, and household linen.**
Applies to textiles, clothing, their accessories and household linen, whose textile composition is greater than 50% in relation to the mass.
- **[NOM-015-SCFI-2007](#), Commercial Information- Labelling for toys.**
Applies to all toys made with any material, including operated with battery operated, batteries and/or any other power source, that are marketed in the territory of the United Mexican States.
- **[NOM-024-SCFI-2013](#), Commercial information for packaging, instructions and guarantees of electronic, electrical, and household appliances**

Applies to new, rebuilt, used or second-hand products, as well as spare parts, accessories and consumables that are marketed in the territory of the United Mexican States.

Spare parts, accessories, and consumables, internal and external, of electronic, electrical, and household products that are intended for bulk sale or for replacement purposes within warranty, do not require the instructions, warranty, or commercial information referred to in this Standard Mexican official, even if they do require warnings when they are dangerous products.

- **NOM-050-SCFI-2004, Commercial Information-General Labeling of products.**

Applies to all products of domestic manufacture and of foreign origin intended for consumers in national territory.

➤ **Legal Requirements to register the Company**

LEGAL DOCUMENTATION (*Only the first time that the inspection service is requested*)

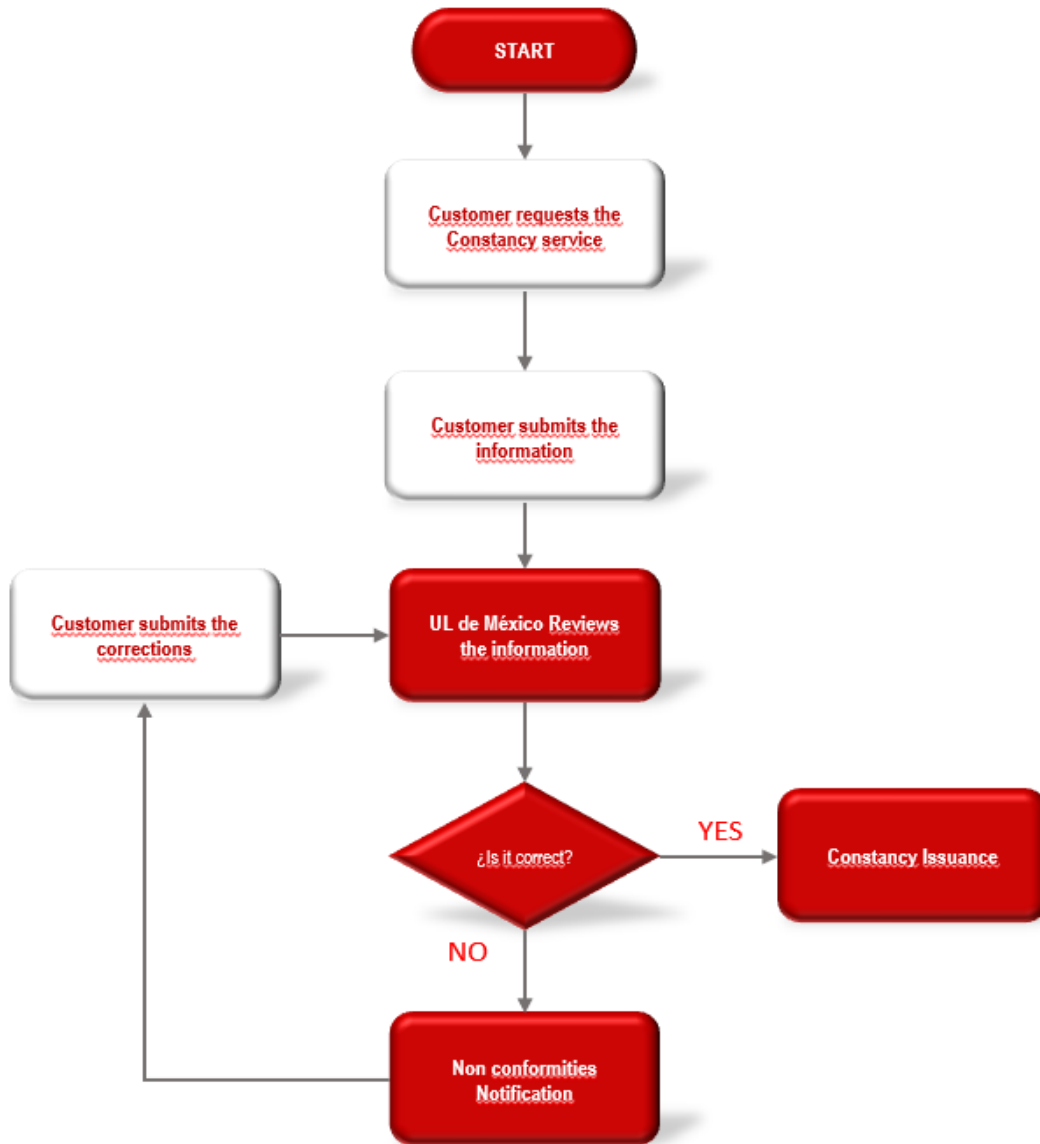
- 1) Copy of the company's Articles of Incorporation.
- 2) Power of Attorney of the legal representative, if not included in the articles of incorporation (in the case of legal entities).
- 3) Inspection Service Contract signed in the corresponding area.
- 4) For natural persons: Official identification and Taxpayer registration .

➤ **Requirements for Constancy**

- A. Application form duly signed by company's legal representative or authorized person.
- B. Label of each model to be evaluated (adherable or printed on the packaging or printed on the product)
- C. Instructions and/or operation manuals*
- D. Warranty*

* Mandatory for NOM-024-SCFI and as applicable for other standards.

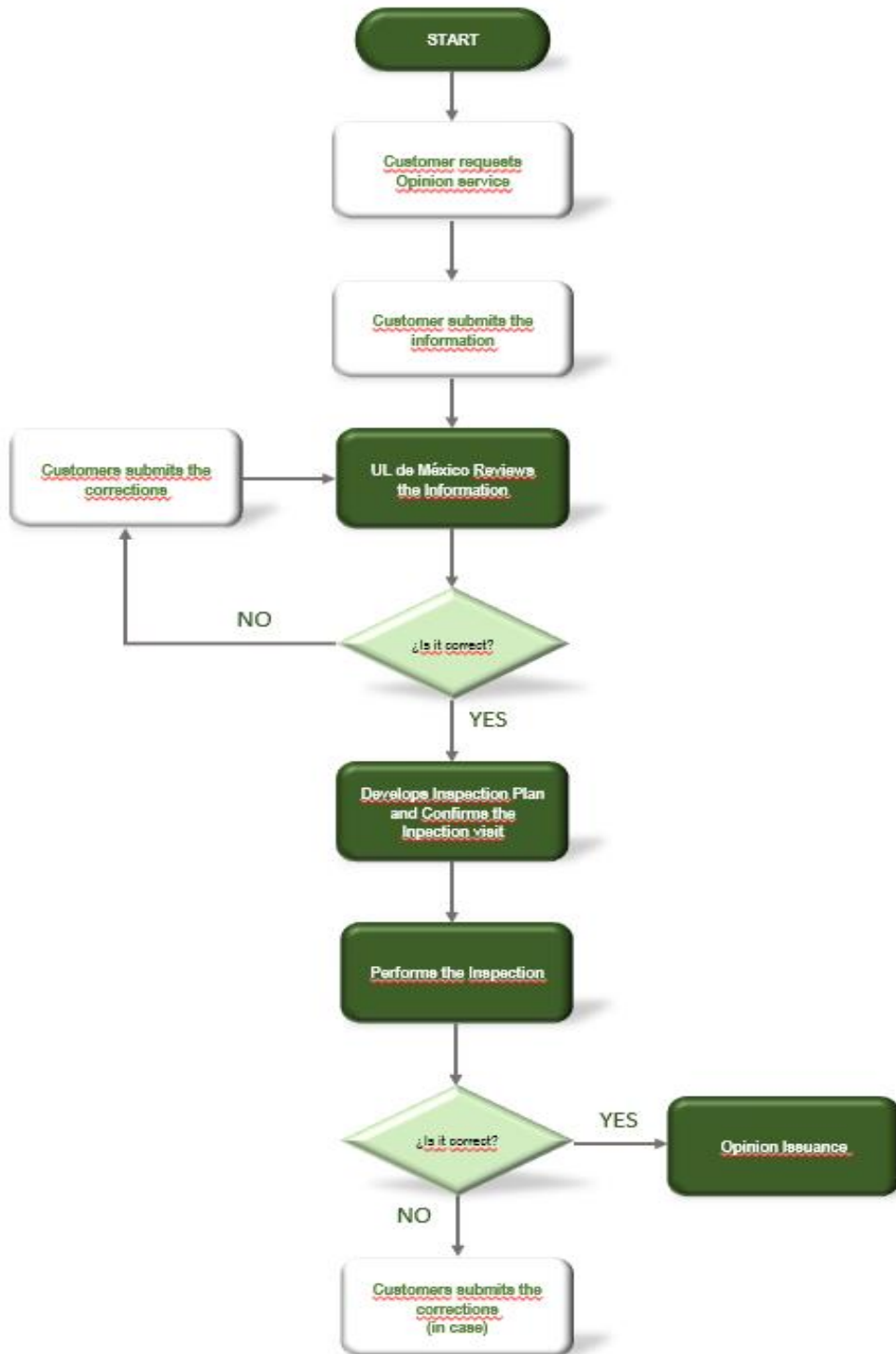

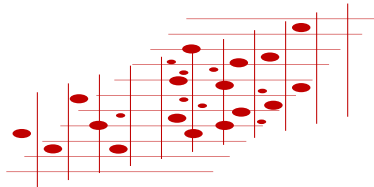
- A. Application form duly signed by the legal representative of the company or authorized person.
- B. Label of each model to be evaluated (adhered or printed on the packaging or printed on the product).
- C. Copy of commercial invoice or shipment
- D. Customs declaration.
